#### Chess

CFHS Chess Team placed 15th overall in National competition. Team members are Zack Cancio, Matthew Coy, Quinn Hudson, Lucas Johnston, and Ryan Thompson. Their coach is Robby Adamson.

#### Odyssey of the Mind (OM)

Ventana Vista's OM team won 2nd place at State and will move onto the World Finals. Team members are: 3rd Graders Audrey Kirk, Natalie Liu, Ezra Mandel, Tessa Strickland, and 4th Graders Ethan Bialis and Arianna DuPont. Their coaches are DeDe Alexander and Tiffanie Bialis.

Manzanita students who are part of the Tucson Children's Museum OM team, finished 1st place in state competition and will go to the World Finals. Team members are Bryce Falkoff, Ava Mercaldo, Jason Mercaldo, Jocelyn Swift, and Jake Toole. They also received the Omer Award, given to only one team in the entire K-12 competition. The award is given to a team that exemplifies teamwork.

#### Shakespeare Competition

Miriam Arden, CFHS student, placed as a semifinalist at the 35th Annual National Shakespeare Competition on William Shakespeare's birthday while competing against 55 students from around the US. Her teacher is Carson Wright.

#### Approval of Middle School (Chinese) and High School (Spanish) World Language Courses (second reading)

Associate Superintendent Mary Jo Conery presented the academic content standards for new courses at the middle school (Mandarin Chinese: Exploring Culture) and high school (Spanish: Community and Culture).

The three proposed courses in the middle school Mandarin Chinese program include: Exploring Culture for grade 6, Investigating Culture for grade 7, and Bridging Cultures for grade 8. Dr. Conery reviewed minor changes that were made to the table of contents and course curriculum scales since the first reading of the middle school (Chinese) course. The first change "Cultural Literacy" to Understanding Culture," change "Critical Thinking: Information and Discovery

(Questioning)” to “Critical Thinking: Inquiry – Information and Discovery (Questioning). The last change reformatted the standard to provide clarity to students working on specific components of the major categories of the ICC Attitudes, Knowledge, and Skills.

Dr. Conery stated that the high school Spanish Communication and Culture course will focus on students with immersion experience or heritage learning background. In this course, students will develop their proficiency in areas of communication by speaking, listening, viewing, reading and writing. Dr. Conery also reviewed minor changes that were made to the course curriculum scales since the first reading of the high school (Spanish) course. The change of “Culture and Community” to “Communication and Culture”, changed the phrase “another cultural group” to “Spanish-speaking cultures,” deleted the word “general” from “using general descriptors” because high school students have the ability to clearly define their performance. And the last change reformatted the standard to provide clarity to students working on specific components of the major categories of the ICC Attitudes, Knowledge, and Skills. The board approved the new World Language courses, as presented.

#### **Approval of Revisions to 2017-2018 Calendar**

Assistant Superintendent Denise Bartlett reviewed the revisions to the 2017-2018 student calendar. Dr. Bartlett reported that due to the school closure from April 27<sup>th</sup> through May 3, 2018, there was a need to revise the calendar. The district administration calculated the total number of instructional hours at each level, and it was determined that the district surpassed the number of total hours required by the state despite the closure. She informed the board that there was no need for students to make up instructional time for the days district schools were closed. Dr. Bartlett reported that there was a need for staff to make up days to fulfill the requirements of their contracts. Added to the calendar were six additional work days after May 24<sup>th</sup>. The board approved the revised calendar, as presented.

#### **Consideration of Revisions to Catalina Foothills School District Performance Award Plan (first reading)**

Dr. Bartlett presented the first reading of the 2018-2019 Performance Award Plan. She reported that last year the district administration recommended some changes that continue to be included in 2018-2019. Dr. Bartlett mentioned the professional learning requirements related to the current School Improvement Plan’s goals, strategies and action steps. Also, the continuing use of AzMERIT and AIMS Science to calculate the school’s overall achievements. For each content area of AzMERIT, the overall school’s scaled score for each grade level will be used to decide the achievement level obtained for the grade. The science achievement will require the school to meet or exceed the expected mean plus or minus an allowance for the standard deviation. Dr. Bartlett reported that the award amount at the end of

the plan has been revised based on the State’s notice to the district on the funding of Proposition 301 for the 2018-2019 school year at \$423.00 per student. This item will return for a second reading at the next regular governing board meeting on May 24.

#### **Approval of Revisions to Policy IC School Year**

Dr. Kamerzell presented the recommended revisions to the district’s current policy. She reported that the school year is defined by the number of days or by the number of instructional hours defined in A.R.S. 15-901. The district administration proposed two revisions to the language. First, substitute the reference to 180 days with a reference to the required number of instructional hours for different program levels. This will provide flexibility when establishing a school calendar. Second, language was added where required by A.R.S. 15-806(B), stating that the Superintendent shall apply to the Arizona Department of Education for authorization of school closures. The board approved the policy revisions, as presented.

#### **Approval of Revisions to Policy ID School Day**

Dr. Kamerzell presented the recommended revisions to the district’s current policy. The district administration recommended the addition of language that would require the Superintendent to apply to the Arizona Department of Education for authorization of school closures. The board approved the policy revision, as presented.

#### **Consideration of New Policy IDA School Closures (first reading)**

Dr. Kamerzell presented the first reading of a new policy regarding school closures. She reported that adding this new policy will bring the district into compliance with the law as stated in the A.R.S 15-806 statute. The board will review this policy for a second reading at its next meeting on May 24.

#### **Consideration of Revisions to High School Career Technical Education Courses (first reading)**

Dr. Conery reviewed the proposed course standards for the high school Career and Technical Education CTE/JTED courses. The 6 courses are highlighted below:

- Chemistry: Biotechnology 2, is the second course in the Bioscience Program.
- Anatomy & Physiology, is the first course in the Sports Medicine and Rehabilitation Program.
- Sports Medicine 2, is the second course in the Sports Medicine and Rehabilitation Program.
- Business & Marketing 1: Entrepreneurship, is being revised to reflect the required industry standards for Business Management.
- Business & Marketing 2: Entrepreneurship is being revised to reflect the required industry standards for Business Management.
- Business & Marketing 3: Entrepreneurship, Career Planning & Personal Finance, and

Career Exploration & Consumer Finance, are two one-semester courses that meet the Arizona Department of Education requirements for Career Exploration.

Dr. Conery reported that these courses would be implemented in August 2018. This item will return for a second reading at the next regular governing board meeting on May 24.

### **Public Hearing on Revisions to Fiscal Year 2018 Budget**

Board President Amy Bhola opened the public hearing for comments from anyone in attendance. No comments were expressed, and the public hearing was closed.

### **Approval of Revisions to Fiscal Year 2018 Budget**

Controller Sandra Thompson reviewed revision #3 of the fiscal year 2018 proposed budget documents that were updated to incorporate the changes to the Maintenance and Operations (M&O) projected revenues and expenses.

- General Budget Limits - Decreased by \$167,640.00 due to a reduction in Average Daily Membership (ADM).
- Unrestricted Capital Budget Limit – Decreased by \$84,457.00 which is based upon 100<sup>th</sup> day ADM for 2017.
- Federal Projects – Increased by \$187,373.00 due to the finalizing of grant funding. E-Rate funding increased by \$243,265.00, due to the filing for a Priority 2 E-Rate reimbursement for hardware purchased during 2017.
- Instructional Improvements – Reduced to reflect the 2018 funding and carry forward amount from 2017.
- Other Funds Budget – Updated to accurately reflect what the district anticipated in expenditures for each of the funds.
- 2017 Budget Balance Carry Forward – Reduced by \$15,694.00 to reflect the July 2017 adjustment by the Arizona Department of Education.

The board provided feedback and expressed their sincere appreciation. The board approved the revised budget, as presented.

### **Fiscal Year 2017 Audit Report**

Ms. Thompson reported that the audit of FY 2017 identified the district as a low-risk auditee and no reportable material weaknesses to the district major federal program awards. Ms. Thompson reported that the audit identified the district as having a deficiency in the area of internal control over the district financial report. A corrective action plan was submitted to ensure future debt service financial transactions are accurately reviewed and recorded. Ms. Thompson also reviewed information regarding findings related to the accuracy of the district accounting records with a transaction where

the account coding was not compliant with the Uniform System of Financial Records (USFR) Chart of Accounts. The 2018 audit will begin on May 14<sup>th</sup>. Ms. Thompson assured the board that the district is committed to meeting all financial regulatory requirements.

### **Fiscal Year 2019 Maintenance and Operations (M&O) Budget**

Dr. Kamerzell gave an update on the FY19 straw budget. She reviewed the proposed changes since the governing board reviewed the budget on April 24. They are additional funds to Prepaid Property/Liability Insurance, University of Arizona Project Focus, Meal Magic Support/Maintenance and a reduction in funding for Prepaid Legal Expense.
